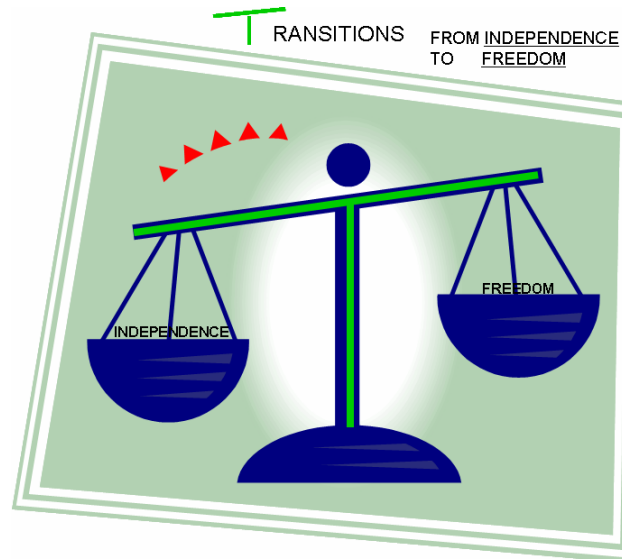

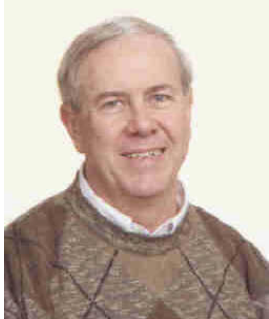

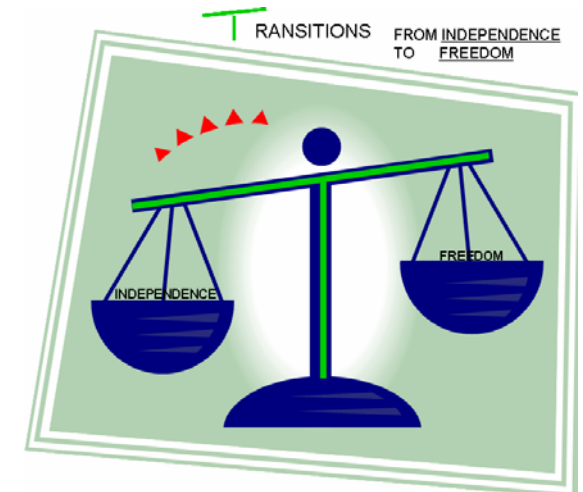

## Attitude Is Critical to Change

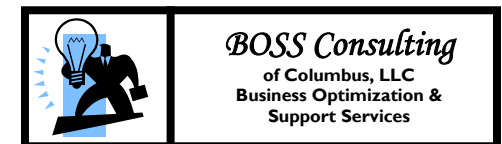
